The “Digital Divide” has plagued America for decades! Families in Rural America and low-income families in Urban America have long been left behind with reliable access to computers and internet service at their homes.




The Biden administration is tackling this problem through a recent \$14 Billion allocation for groups like Heritage Wireless to provide these services to Americans (with government support).



Heritage Wireless Group’s mission is to be a national leader/facilitator in providing the public with accessible and reliable means of communication through equipment and wireless internet service.



We intend to distribute at least 1 million tablets to deserving families (ie. Students on Free and Reduced Lunch, Medicaid Recipients, Pell Grant Recipients, etc.) over the next year! We would like to count your organization into our goals!



# OUR AGREEMENT

**As Of January 2023, The Federal Communication Commission has Initiated A New Program In Response To Closing the “Digital Divide”. We desire to deliver these benefits to 1 million families, including your organization. Here are our proposed MOU terms...**



We will provide a FREE Tablet (or Smart Phone) and up to 5 years of wireless internet service to ALL students in your school/district who are on the FREE and REDUCED LUNCH PROGRAM or who meet any of the other eligibility criteria.



This will be provided at NO COST and with NO FINANCIAL IMPACT to your school/district as our costs and expenses are reimbursed through the Federal Government.



We have the capacity to immediately onboard up to 20,000 students per month and will be able to accommodate up to 100,000 students starting in January.



The primary requirement for your students/families is that they will have to meet one of the eligibility criteria and will have to certify that they will use the tablets and service for themselves (and not resale them). They may be subject to a \$12 (\$1 per month) renewal fee after the first year of service.



We will work with your school/district staff to determine ...

- 1) What customizations and licensed apps are desired on the tablets
- 2) The process to receive the required Eligibility Verification information
- 3) What is the most efficient process to distribute the tablets and sim cards
- 4) The timing and sequence of tablet deliveries

# WHO CAN PARTICIPATE



**A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the [Federal Poverty Guidelines](#), or if a member of the household meets at least *one* of the criteria below:**



## **Other Eligibility Criteria:**

- **[Received a Federal Pell Grant during the current award year;](#)**
- **Meets the eligibility criteria for a participating provider's existing low-income internet program;**
- **Participates in one of these assistance programs:**
  - **[Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture \(USDA\) Community Eligibility Provision schools.](#)**
  - **SNAP**
  - **Medicaid**
  - **Housing Choice Voucher (HCV) Program (Section 8 Vouchers)**
  - **Project-Based Rental Assistance (PBRA)/202/811**
  - **Public Housing**
  - **Supplemental Security Income (SSI)**
  - **WIC**
  - **Veterans Pension or Survivor Benefits**
  - **or [Lifeline](#);**
- **Participates in one of these assistance programs and lives on [Qualifying Tribal lands](#):**
  - **Bureau of Indian Affairs General Assistance**
  - **Tribal TANF**
  - **Food Distribution Program on Indian Reservations**
  - **Tribal Head Start (income based)**
  - **Affordable Housing Programs for American Indians, Alaska Natives or Native Hawaiians**



**There are multiple ways to be eligible for our FREE Tablet and Wireless Internet Service Program. Once eligibility is verified, wireless service can continue for up to 5 years. # HOW TO PARTICIPATE



We must have individual or batch applications that we submit for Eligibility Verification.



Either the school/district can provide a full list of its students for batch approval and processing OR we can provide internet links and paper applications to each student/family.



Upon confirming eligibility, we will deliver (to the home or to the school) the tablets for each student/household. Instructions will be included on how to immediately activate the wireless service.



We will have a 24/7 toll free number for any technical service needs on the wireless service. Additionally, each tablet/device comes with a 1-yr manufacturer's warranty



Each year, the user will self certify that they meet the criteria and will honor all terms and conditions.



Let's jointly close the "Digital Divide" and have a new learning tools available to each student to reinforce your academic program

# PROPOSED NEXT STEPS/DISTRIBUTION PLAN



Review and Execute our Memorandum of Understanding (MOU) memorializing our authorization to begin distributing tablets and wireless service at no financial cost to the School/District or your Students/Households.



Have the appropriate school/district staff to estimate the number of students that qualify for the program so that we can allocate the implied number of tablets and sim cards needed. Additionally, to support us in collecting/obtaining the required eligibility verification.



Agree on the proposed process and timing to distribute tablets to your students.

NOTE: Our preference is to dropship directly to the homes, but we are open to other desired accommodations.



Schedule in-person and/or online webinars across the school/district to provide desired training on the tablets to students, parents, staff, etc.
